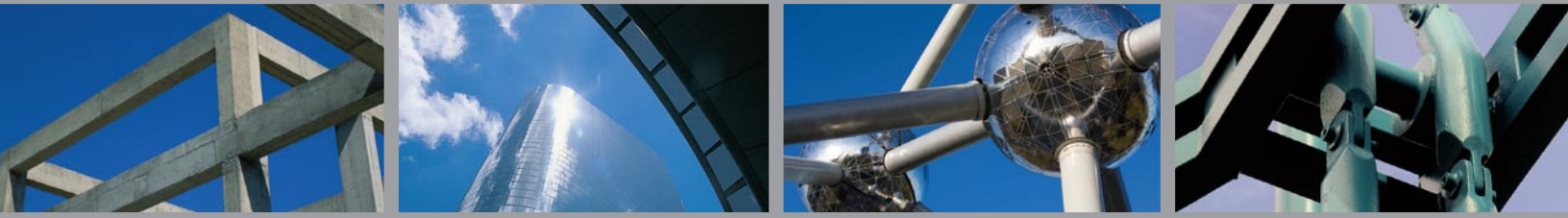

The database, which contains records of blocked companies, associations, individuals, government officials and locations, is updated each time the U.S. Treasury's OFAC list is modified—sometimes daily—giving you the most up-to-date information available. Accuity also offers many additional lists within our Global WatchList® database that may be added for comprehensive regulatory and enhanced due diligence screening.

Using the Good File module, false positive matches can be flagged to prevent subsequent hits in future searches.

To further combat false positive matches, built-in screening parameters can be activated and Accuity's Rules Module can be used to ignore common false matches. Once your screening is complete, records can be viewed, transferred and annotated with a user-friendly on-screen interface.

In addition, iCIF offers a data matching screening technique called the Advanced Matching Algorithm, designed to catch unexpected misspellings, transposed letters, double letters and more. This is just one more option to keep you on top of your compliance efforts. Also, when used in conjunction with Accuity's Private File Creator, FACFilter for CIF allows you to screen against your own institution-specific list of blocked entities, giving you more control and unlimited due diligence options.
